

**MINUTES OF CITY COUNCIL
CITY OF SARGENT, NEBRASKA
Regular Session
Sargent Community Center
October 12, 2006**

Legal and Public Notice being duly given as required by law, the regular session of the Mayor and Council of the City of Sargent, Nebraska, was called to order at 7:00 p.m., by Mayor Griebel. The following council members were present at roll call: Nitchie, Kozeal, Oeltjen and Mankle. Absent: None.

Nitchie made a motion to approve the consent agenda for the agenda; the claims presented to date; the meeting minutes for August 14th, 24th, 31st, September 7th and 18th, and the financial report dated September 30, 2006. Kozeal seconded the motion. Vote all yea.

Solutions for repairs to two roads were discussed. The south end of Broadway, going down to the river, is owned by the City and the Township. The City has been taking care of the road. The Council agreed to explore the possibility of sharing some of the cost with the Township for maintenance. It was agreed to have Council members attend the next Township meeting to discuss this with their board. Another road discussed was the north end of Center Street. It was agreed to go ahead and put additional gravel down to maintain this street.

The Council discussed the current contract the City has with Municipal Energy Agency of Nebraska (MEAN). The Council agreed to wait for now and continue on with the contract now in place.

The economic development loans were reviewed. Nitchie made a motion to determine the status of any liens on each economic development loan the City has out. Mankle seconded the motion. Vote all yea.

The liquor license application submitted by William Kidder dba "The Cedar Bar & Grill" Class "C" Liquor License was reviewed. Kozeal made a motion to approve the application. Oeltjen seconded the motion. Vote all yea.

Police Chief Keefe had his employee evaluation with the City Council.

Officer reports were given.

Kozeal moved to adjourn. Oeltjen seconded. Vote all aye. Meeting adjourned at 8:30 p.m.
